COMPOSITION COMMENTS: Two component polyester resin based product. Base component is based on polyester resin.

3 HAZARDS IDENTIFICATION

May cause sensitisation by skin contact.

4 FIRST AID MEASURES

INHALATION: Move the exposed person to fresh air at once. Provide fresh air, warmth and rest, preferably in a comfortable upright sitting position. Get medical attention if any discomfort continues.
