#### 3 HAZARDS IDENTIFICATION

Irritating to skin.

**OTHER PROTECTION:** Wear appropriate clothing to prevent repeated or prolonged skin contact. Wet cement burns are painless, prevention of contact with skin is vital. Provide eyewash station.

**HYGIENIC WORK ROUTINES:** Wash at the end of each work shift and before eating, smoking and using the toilet. Wash promptly if skin becomes contaminated. Promptly remove any clothing that becomes contaminated. No eating or drinking while working with this material. **DO NOT SMOKE IN WORK AREA!**
